

Environmental Policy

As a delivery partner for Investors in the Environment (iE), Genee is committed to demonstrating environmental best practice within its own operations as well as through its client work.

The organisation recognises that our activities have environmental impacts and has identified its significant environmental aspects as energy and water consumption, waste generation, transport emissions (including business travel and commuting), procurement of goods and services, and digital carbon emissions.

This policy sets out Genee's commitment to environmental management, compliance, and continual improvement, and demonstrates how these commitments align with the United Nations Sustainable Development Goals (SDGs).

Environmental Policy Statement

Genee is committed to protecting the environment, preventing pollution, and reducing the environmental impacts of its activities. They will integrate environmental considerations into all business decisions and operations and will support its clients to do the same.

Genee is committed to achieving Net Zero greenhouse gas emissions by 2030, reducing resource consumption, and contributing to sustainable development locally and nationally.

This policy provides the framework for setting environmental objectives and targets and will be reviewed annually to ensure its continued suitability and effectiveness.

SDG 13: CLIMATE ACTION

Genee measures and monitors our greenhouse gas emissions annually and implements actions to reduce emissions in line with our commitment to achieving Net Zero by 2030.

We will prioritise reductions in travel related emissions and digital carbon impacts and will support clients in developing and implementing carbon reduction strategies.



SDG 7: AFFORDABLE & CLEAN ENERGY

Genee monitors energy and water consumption and implements measures to improve efficiency. This includes adopting low energy working practices, promoting responsible energy use among staff, and supporting the transition to renewable energy where feasible, as part of this commitment we are now on a solely green tariff and have installed solar panels.

Genee manages our waste in accordance with the waste hierarchy, prioritising reduction, reuse, and recycling. We have implemented a Waste Management Plan and ensure that procurement decisions consider environmental impacts, including lifecycle considerations.

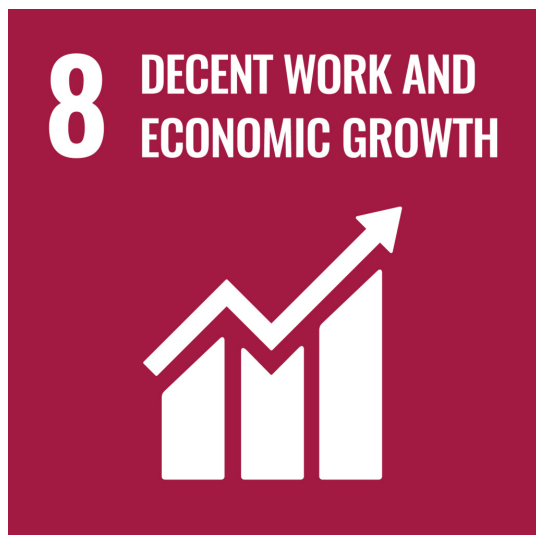


Environmental Commitments and Objectives

Genee operates an Environmental Management System aligned with the requirements of Investors in the Environment. The EMS provides a structured approach to identifying environmental aspects, setting objectives and targets, implementing action plans, and monitoring performance.

The organisation will maintain documented procedures and supporting plans, including an Environmental Action Plan, Travel Plan, and Waste Management Plan, to ensure that commitments within this policy are implemented effectively. Environmental performance data, including energy use, waste, and carbon emissions, will be collected, analysed, and reviewed regularly.

Genee will comply with all applicable environmental legislation, regulations, and other requirements relevant to its activities. We will maintain awareness of legal and regulatory changes and ensure that its operations remain compliant at all times.

Roles, Responsibilities and Competence

Overall responsibility for environmental performance lies with senior management. Day-to-day implementation of this policy is led by our designated Sustainability Champion, Ellen Holmes, who is responsible for coordinating environmental actions and monitoring progress.

All employees are required to support the implementation of this policy by adopting sustainable working practices and contributing to environmental objectives. Genee will provide appropriate training and awareness to ensure staff are competent to fulfil their responsibilities.

Communication and Stakeholder Engagement

This policy will be communicated to all employees and made available to clients, stakeholders, and the public. Genee will actively promote environmental awareness and engagement through its work, training, and communications.

We will also seek feedback from stakeholders to inform continual improvement and enhance our environmental performance.

Monitoring, Review and Continuous Improvement
